Terms and Conditions

1. I agree to pay the annual tuition on or before April 1, 2010.
2. Tuition for Post Grads is refundable until Jan 1, 2010, less \$200.00. After Jan 1, 2010 tuition in the Post Grad program is non-refundable.
3. Tuition for Grad 1 and 2 is refundable until April 1, 2010 less \$200.00. After April 1, 2010 tuition is non-refundable regardless of the reason for withdrawal. It is understood that no refunds will be made for sickness, transportation delays or withdrawals.
4. Between April 1, 2010 and June 1, 2010, any possible changes to Teen Travel Program will incur a \$50.00 charge per change.
5. After June 1, 2010, any possible changes to Teen Travel Program will incur a \$50.00 charge per change in addition to the cost of any tickets that have been purchased on behalf of your child.
6. Ivy League Day Camp has the unrestricted right to terminate this enrollment agreement at its sole discretion. In the event of such termination, Ivy League Day Camp will not refund any unused portion of the tuition.
7. Ivy League is not responsible for any camper's belongings lost or damaged at camp.
8. Ivy League Day Camp has permission for my child to participate in all camp programs, overnights and trips that are planned and supervised by Ivy League Day Camp.
9. Ivy League Day Camp has permission to reproduce and publish any photograph, video or likeness of my child for advertising, camp web sites, commercial or any lawful purpose.
10. In the event that a parent or the family physician cannot be contacted in an emergency, Ivy League Day Camp has the permission to have my child examined at a hospital emergency room.
11. Ivy League's camp calendar is based on a 39 day camp. Ivy League will be closed Monday, July 5, 2010.
12. I understand that any changes in calendars, itinerary, arrival time, travel communication and information about upcoming events will be done through e-mail and/or the Camp Portal.
13. I give permission for Ivy League to release my child's name, address and phone number to the other children in his/her group for the 2010 camp season.
14. Arbitration: I agree that any claim or dispute regarding this contract, the literature concerning the Camp, the attendance of my child at the Camp, or anything that relates to the camp experience itself, shall be resolved exclusively by binding arbitration in Suffolk County, New York, according to the then existing commercial rules of the American Arbitration Association.
