**AGREEMENT**

1. I agree to pay the total tuition as per the selected payment plan.
2. **(Plans A or B)** Tuition is refundable until April 30, 2010, less a \$200.00 non-refundable processing fee. Between April 30, 2010, and September 1, 2010, tuition will be refundable less the 10% initial deposit. After September 1, 2010, Ivy League will refund 80% of your tuition or the prorated tuition, whichever is less. It is understood that no refunds will be made for school closings, sickness, or transportation delays. **(Plan C)** Any withdrawal from either school or camp will result in immediate withdrawal from this incentive package payment option. The individual refund policy for either camp or school will then apply.
3. The Ivy League School has the unrestricted right to terminate this enrollment agreement at its sole discretion. In the event of such termination, the Ivy League School is not obligated to refund tuition or any unused portion of the tuition.
4. The Ivy League School has permission for my child to participate in all school programs and trips that are planned and supervised by the Ivy League School.
5. The Ivy League School has permission to reproduce and publish any photograph, video or likeness of my child for advertising, commercial or any lawful purpose.
6. In the event that a parent or the family physician cannot be contacted in an emergency, the Ivy League School has my permission to bring my child to a hospital emergency room.
7. I agree that any claim or dispute regarding this contract, the literature concerning Ivy League School, the attendance of my child at the school, or anything that relates to the school experience itself, shall be resolved exclusively by binding arbitration in Suffolk County, New York, according to the then existing commercial rules of the American Arbitration Association. In any such arbitration the substantive (but not procedural) law of the State of New York shall apply.
